On 13 March 2019, the Committee enacted **the amendments** specified with strikethrough and underline in **the entry** below on its List of individuals and entities subject to sanctions- assets freeze, travel ban, and arms embargo- set out in paragraph 1 of Security Council resolution 2368 (2017) and adopted under Chapter VII of the Charter of the United Nations.
